BACKGROUND INFORMATION RELATED TO RESEARCH FOCUS

Provided by Client Prior to Research

John Geary was born c. 1790 in **Centre County, Pennsylvania** (unknown county prior to 1800) and died c. 1876 (DAR), unknown location. He married Juliana Carner (1794-1862) c. 1818 (birth of first child). She was born 1794 **Sandy Ridge, Centre** – unknown county prior to 1800 (client report). Juliana's father was Anthony Carner (1752-1834), a revolutionary war soldier (DAR) who d. **Centre**. Their children were Susan (Geary) Hall (1819-1911), b. Penn. (DC); Catherine (Geary) Butler (1823-1870), b. Elk Co., Penn. (child's DC); Thomas Jefferson Geary (1826-1908), b. **Centre**. (DC); William Carner Geary (1834-1916), b. **Hublersburg, Walker, Centre** (DC); and Benjamin Frank(?) Geary (1838-????). John may be listed in Pennsylvania in the following federal census records: 1820 in Hartleton, Union; 1830 in Brothersvalley, Somerset; and 1840 in **Walker, Centre**. The client is looking for distant relation to John White Geary (1819-1873), former governor of Pennsylvania

Analysis of Provided Information

The above information was reviewed. It is important to research the Geary line back far enough to see if there is a common ancestor between John Geary (1790-1876) and Governor John White Geary (1819-1873). The initial research will be to find the parents of John (b. 1790) and continue back to find a common ancestor. John (b. 1819) has many family trees on line that will also need to be verified at some point. The 1820-1840 census records need to be checked for Geary household members of the correct age.

<u>Analysis:</u> Centre County was formed in 1800, so John and Juliana (Carner) Geary were certainly born in one of Centre County's parent counties. As most of the family's life events occurred in Centre, it is likely they lived most of their married life there. Below is a timeline table incorporating information provided by the client with information discovered in this current research phase.

SUMMARY OF KEY FINDINGS

While every effort has been made to meet the conditions of the Genealogical Proof Standard, time constraints have restricted the research. The conclusions in this report are based on information in the records reviewed and cited within. Continued research may reveal inconsistencies or inaccuracies and could lead to new conclusions.

The John Geary family was documented in reports or records, living in Union and Centre Counties until about 1860. They likely lived most of their married life in Walker Township in Centre County. John Geary left Walker. Based on the timeline, it appears that John Geary moved away c. 1842 after selling property in Walker Township to Anthony Carner (not in 1850 census). Juliana (Carner) Geary lived in Boggs Township with her son until at least 1860, implying a death after 10 Apr 1863 (medical receipt from prior report) and before 1870. As Centre was formed in 1800, John may have been born in one of the counties that Centre was formed from, namely Northumberland, Mifflin, or Huntingdon.

Walker Township may have been a part of Northumberland County prior to becoming a part of Centre County in 1800, where John Geary is said to have been born. A Thomas Geary was born c. 1760 and died on 15 Sep 1840 in Northumberland. Other land and tax records support his residence. None of this information proves the father-son relationship, but may lead to this conclusion when combined with new evidence.

No evidence in DNA or records points to a relationship between John Geary (b. 1790) and John White Geary (b. 1819). Only one family, that of Thomas Geary of Northumberland, had a male living in his household in 1800 that was of an age consistent with John Geary (under 10, b. c. 1790-1800).

ITEMIZED RESEARCH FINDINGS

The following records were scanned, photographed, and/or copied and analyzed. Citations were placed on each accompanying image with a cross reference to their appropriate exhibit (Ex) and footnote (Fn). All analytical comments about the records are in *italic*. Digital images of designated exhibits will be emailed for easier examination by the client.

Census Records (Exhibits 1-4)

The federal government conducted a census every ten years, beginning in 1790. The Pennsylvania Septennial Census was conducted every seven years from 1779-1863. Census records provide information about individuals, families, and communities. They can help find a family's residence and trace its migration. People enumerated next to each other or in the same general area may be relatives, families who moved together, or families that intermarried. Other types of census records include agricultural, industry and manufacturing, mortality, etc.

John Geary Households in Census Records:

The client provided four census records, 1820-1850, as potential John Geary households.

- 1820 U. S. census: John Geary household in Hartleton, Union County¹
- 1830 U. S. census: John Geary [Geasy] household in Brothersvalley, Somerset County²
- 1840 U. S. census: John Geary household in Walker, Centre County³
- 1850 U. S. census: Julian Geary household in Boggs, Centre County⁴

<u>Analysis:</u> Records and genealogical reports show John Geary and/or members of his family living in Centre County, Pennsylvania from John's birth (1790) through the Civil War registrations of Thomas and William Geary (1863). Family members inconsistently fit into the 1820 and 1840 census records. They may be the same family found in the 1840 and 1850 Centre County census records, but additional evidence is needed. Likewise, a female of Susan Geary's age is not in the 1840 census, as she was married by 1837. The 1840 census lists two individuals "engaged in manufacturing," likely John and the unknown male age 20-29. It is not known what type of manufacturing John was employed in. The 1830 census is the only census that does not fit neatly with this family.

Also, John is not listed with his wife, Juliana, and youngest son, Benjamin, in 1850, implying a move or death c. 1840-1850 at age 60-70. Juliana disappears in 1850, also implying a move or death c. 1850-1860 at age 56-66.

<u>Analysis:</u> Thomas Geary households with a male child the correct age of John Geary was found in Northumberland County from 1790-1840. Thomas was not found in 1810, 1820, and 1850 (likely died by 1850). His family members fall neatly into the consistent birth categories for these 4 census records. Based on the analysis and correlation of these four census records, Thomas was likely born c. 1760-61. Thomas's assumed wife was likely born c. 1756 and would have been of child-bearing age (about 34) in 1790. No other Geary households (with or without a male child of the correct age) were found in central Pennsylvania.

If born in 1790, John Geary would not have been born in the current Centre County (formed in 1800), but in either Huntingdon, Mifflin, or Northumberland. No Geary households with a child born c. 1790 were found in Huntingdon or Mifflin Counties during this same time period. John may or may not appear in the 1790 census, depending on his birth month that year. He could have been one of two males under ten in the Thomas Gery household in Northumberland in the 1800 census. John was likely married by 1819 and heading his own household in 1820 in Union County. Union was formed from Northumberland in 1813.⁹ John and Thomas are also found in his own household in 1840. John also named is oldest son, Thomas (1826-1908), possibly after his father.

Land and Property Records (Exhibits 5-9)

Land records exist for periods of time for which other records are not available. Deeds can place families in a particular location and time. They can also provide information on a person's current and/or former residence and occupation, spouse, and other relationships. Family members may be listed as witnesses, neighbors, etc. Land records can also help differentiate same-named people.

Centre County was formed in February 1800 from three counties; specifically, the south-eastern part from Huntingdon, the eastern part from Northumberland, and most from Mifflin.¹⁰ Union County was also formed from Northumberland in 1813. A Thomas Geary submitted land warrant applications on three Northumberland land properties and one Mifflin County properties (1792-1794).

<u>Analysis:</u> The same Thomas Geary likely purchased and settled on land in 1792 and 1794 in Muncy Township, north of the West Branch of the Susquehanna River in northern Northumberland County. Muncy became part of Lycoming County when Lycoming was formed from Northumberland in 1795. It is not known if he moved from the 1792 property (100 acres) to the 1794 property (400 acres). However, he never appears to have settled on the 1793 parcel and was not likely the same person who purchased the 1794 Mifflin property, approximately 70 miles away, without moving his family.

Hartleton, Union County is approximately forty miles south-southwest of Muncy, and the area was once located in Northumberland. If born in 1790, John may have grown up in Muncy, then struck out on his own for Union County.

Tax Records (Exhibits 10-13)

County tax records can help place a person in a particular place and time. Examination of tax lists over a period of years may reveal dates of settlement, migration, marriages, deaths, approximate ages, and family relationships. Taxpayers may be categorized as freeholders (property owners), tenants, or single men. Early tax lists consist of taxes on people, land, and personal property. In addition, the taxes someone paid can imply their economic status, which can help to distinguish between two same-named people. The Franklin County Archives holds tax records from 1786-1807 (not inclusive) and 1848-1911. Tax records from 1808-1847 can be found at the Pennsylvania State Archives.

A Thomas Geary/Geary/Goary/Gary paid taxes in Northumberland, Lycoming, and/or Mifflin Counties from at least 1787-1800.

- 1787 Pennsylvania Tax & Exoneration: Thomas Gary was taxed on one house and one lot in Point Township.¹⁵
- 1798 U.S. Direct Tax: Thomas Gearry was taxed in Northumberland, Lycoming, or Mifflin Counties¹⁶

- 1800 Pennsylvania Septennial Census: Thomas Geary was taxed in Point Township, Northumberland County¹⁷
- 1800 Pennsylvania Septennial Census: Thomas Goary, a farmer, was taxed in Muncy Creek, Lycoming County¹⁸

<u>Analysis:</u> A Thomas Geary owned land in Northumberland and Lycoming County by 1792. A Thomas Geary was taxed from at least 1787-1800 in Northumberland and Lycoming (and possibly Mifflin) Counties. This property could have been located in the future Centre County (formed 1800). There is no proof that one or all of these men were the father of John Geary. However, there are no others of the same or similar name in the area where John Geary was reportedly born (Centre County).

The Pennsylvania State Archives is currently closed due to Covid-19, so additional tax records for Northumberland, Mifflin, and Union Counties cannot be checked at this time. The state archive does not hold records for Lycoming.

Newspaper Articles (Exhibit 14)

Newspaper articles can give information on vital events such as births, marriages, and deaths. They can also provide additional insight into a person's education, career, political and community activities, and life in general. Other articles may include local news, real estate transactions, business advertisements, probate court and legal notices, or biographical sketches.

"Died at Northumberland, on the 15th inst. [15 Sep 1840] Mr. Thomas Geary, aged 80 years, an old resident of that place."¹⁹

<u>Analysis:</u> As a resident of Northumberland, it is likely that this is the same Thomas of Northumberland census, land, and tax records (1790-1840), disappearing from census records by 1840. Born c. 1760, he was about 30 years old when John Geary of Centre County was born, well within the age range for fathering children.

DNA

Used in combination with traditional genealogical research, DNA can help prove genetic relationships. Y-Chromosome DNA (Y-DNA) is useful for tracing the father's line back from father to father to father. Mitochondrial DNA (mtDNA) can trace the maternal line back through each mother's mother. Autosomal DNA is used to confirm familial relationships within 5-6 generations. Only men can test for Y-DNA, but both men and women can test for autosomal and mtDNA.

Genealogy Report for Terry Zerwick

The client's autosomal DNA test results are posted at Ancestry. The following searches were performed to determine if any matches posted family trees that contained the father of John Geary (b. 1790), specifically a common ancestor that connects John Geary with John White Geary (1819-1873).

<u>Analysis:</u> The following searches were performed for matches to the client with the Ancestry DNA database:

- Search for all matches: The client matched 4 proposed second cousins (513-207 cM) and 20 proposed third cousins (189-91 cM). Of these 24 matches, only 16 had publicly accessible trees. Of these 16 trees, none listed a potential father for John Geary b. 1790, and none contained John White Geary.
- Search for matches with Geary surname: 5 matches were listed with a Geary or derivative of Geary. None of these matches had trees with more than 10 people, resulting in only 2-3 generations of ancestors.
- Search for matches with Geary ancestors + Centre County: 4 matches listed Gearys in Centre County. None of their trees listed possible fathers for John Geary, and none contained John White Geary
- Search for matches with Geary ancestors + Northumberland County: No matches

Unfortunately, DNA searches revealed no potential parents for John Geary. There is also no evidence that John Geary and John White Geary share a common ancestor. However, if there is a common ancestor that goes back further than 5 or 6 generations, shared DNA may not show up in autosomal tests.

Other Sources - Centre County Research Request (Exhibit 15)

It is helpful to survey other documents that may not be original. It is important to understand that any of these findings must be evaluated further, but they can offer clues on which direction to take the research. In addition, county histories can provide an insight to the development of the county and migration patterns.

A research request was made to the Centre County Library and Historical Museum on 3 July 2020. Results were returned on 4 September 2020 and are listed below:²⁰

<u>John Geary</u>

- History of Walker Township 1810-1999 (Bellefonte: Walker Township Historical Committee, 1999).
 - o About 1824: Geary family moved to the Nittany area from Hartleton, Union County
 - 25 May 1826: John Geary purchased land to build the Nittany Inn, located at Nittany, Walker Township: <u>https://www.facebook.com/CentralPAHistory/posts/888601874902302</u>
 - o 30 Apr 1830: John Geary sold the inn to Irvin and Huston; moved to Hublersburg
 - 0 1832: exchanged Nittany Inn land with Andrew McKee for the Hublersburg Tavern
 - April 1840: John Geary inn to John Orr and left wife Julia and daughter Susanna (Geary) Hall (1937) "for parts unknown"
- Walker Township, Centre County tax assessment, 1834, John Gairy, occupation tailor.
 - o John Gairy was taxed on land, house and lot of A. McKee, horses, and cows
 - His occupation was listed as a tailor (census)
- Centre County deeds, article of agreement, John Geary to William Carner, 5 Dec 1838 to 9 Jul 1842, deed book D13:522.

- John Geary of Walker Township, Centre County agree to sell land to William Carner of the same place
- Sale to be completed by 1 June 1839
- o Eight acres in Walker Township adjoining lands of Harrison and William Carner
- For the sum of \$180; \$5 at signing; "the amount of a judgement which he holds on the Prothonotary's Docket in Bellefonte against" John Geary
- Payment by 1 Jan next and the balance "after deducting the aforesaid five dollars and the amount of said Judgement"
- o Signed by John Geary and William Carner
- 0 Payments
 - 5 December 1838: \$5.00
 - 4 January 1839: \$149.74
 - 8 May 1839: \$20.00
 - 7 June 1839: \$20.00
- In Apr 1840 John Geary and William Carner told James Burnside "to write the deed in pursuance of the within Article of Agreement," but the deed was not written
- Sworn and recorded 9 July 1842: "John Geary left Centre County . . . not long after the conversation above described for the west—and has never returned"

<u>Analysis:</u> John Geary moved his family to Centre County from Hartleton, Union County c. 1824. He opened an inn, then traded properties with Andrew McKee. An 1834 tax record shows that he did not own the land but was paying taxes on Andrew McKee's property. In 1838 John signed Articles of Agreement with William Carner who paid off the deed for a total of \$194.74 by April 1840. William was likely the brother of John's wife, Juliana. John appears to have left Centre County after the sale of this property was completed. The Walker Township History states that John sold the Hublersburg property to John Orr; however, the recorded deed says the property was sold to William Carner. The 1834 tax assessment lists John as a tailor. The 1820 census lists one person engaged in manufacturing, and he may have worked for a manufacturer at that time.

 - 11 Apr 1839: applied for widow's pension
 - o Children: William, John, and Julia
- Obituaries for Anthony Carner (11 Jun 1886) and Mrs. Anthony Carner (26 Aug 1887), *Democratic Watchman*.
 - o Anthony Carner died 7 June 1886 in Hublersburg, "age about 67 years"
 - 0 Mrs. Anthony Carner died 22 August 1887 in Hublersburg

<u>Analysis:</u> It appears that the Anthony Carner family lived in Union County when John Geary lived there. He likely married Catherine Carner in Union. Based on timing, their first child, Susan, was also born in Union.

Other Geary Families

- Commemorative Biographical Record of Central Pennsylvania: Including the Counties of Centre, Clinton, Union, and Snyder (Chicago: J.H. Beers, 1898), for D.B. Geary, Reuben Geary, Valentine Geary.

 - Reuben Geary was the father of D.B. Geary and son of Valentine Geary
 - o Valentine Geary, a tailor, was the grandfather of D.B. Geary
- John White Geary

<u>Analysis:</u> None of these Geary families appear to be closely related to John Geary b. 1790. However, he may be distantly related to D.B., Reuben, and Valentine Geary. Based on the birthdate of D.B., John and his father may be brothers or cousins. However, there is no mention of this Geary family ever living in Union County. None of the John White Geary records name John b. 1790 as a relation. No DNA matches list any of these other Gearys in their family trees.
